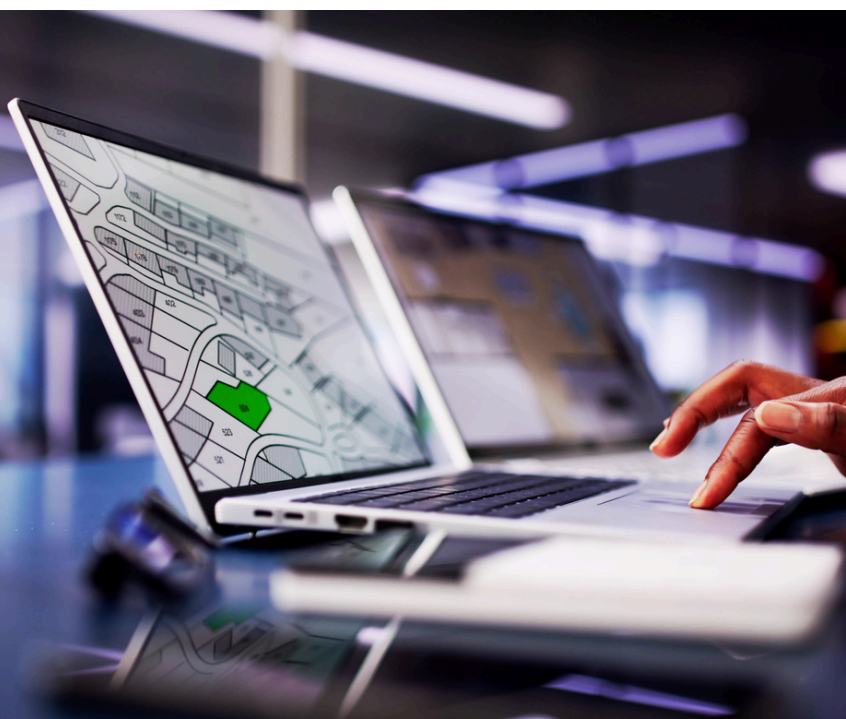
THE POSITION

Information Technology Central (ITC) is looking for a Technology Specialist III to join the Geographical Information System (GIS) Team. This role involves spending 60% of the time working in the Planning and Community Development Department. The remaining time will be dedicated to providing GIS support to other County departments that receive direct support from ITC.

The core functions of the position include creation of GIS maps and graphics for use in public reports and presentations; creation and maintenance of department specific GIS layers like Sectional District Maps and updating zoning designations; and fulfilling customer map requests. This role involves a blend of scientific research, technical skills, and artistic flair to transform raw geographical data into informative and visually engaging maps.

TYPICAL TASKS

- Analyzing spatial data using Geographic Information Systems (GIS) software;
- Perform GIS layer updates;
- Designing and updating maps, charts, and diagrams, ensuring the accuracy and precision of spatial information;
- Collaborating with other professionals such as city planners, environmental scientists, and engineers;
- Preparing and presenting maps and spatial data reports to clients or stakeholders;
- Act as a GIS technical resource for staff, provide support for GIS applications requiring specialized expertise, test programs and applications from the user's perspective, may troubleshoot new applications and/or systems to ensure functional operation;
- Troubleshoot, debug, and resolve a variety of operations/business-process related GIS applications issues;
- Coordinate and provide technical support to County personnel, in-person and over the telephone;
- Use understanding of business operations to help identify potential enhancements efficiencies, define user requirements, design basic solutions; and
- Perform other related duties as assigned.

MINIMUM QUALIFICATIONS EDUCATION & EXPERIENCE PATTERN I

- Two (2) years of experience providing technical support of computer applications and equipment at a level equivalent to Technology Specialist II in Stanislaus County.

PATTERN II

- Equivalent to the completion of an Associate's Degree from an accredited college or university with major coursework in computer science, information technology, or a related field. Possession of an approved information systems technology certificate, or completion of an approved information systems training course may substitute for all or part of the above required education; AND
- One (1) year at a level equivalent to Technology Specialist I in Stanislaus County.

DESIRABLE QUALIFICATIONS

In addition to the minimum qualifications, applicant screening will focus on the following desirable qualifications. Please list any of these qualifications you may have within the "Duties" section of the online application.

- Two (2) years experience creating GIS maps and graphics using ESRI ArcGIS Pro, for use in public reports and representations; OR
- Two (2) years experience updating existing GIS layers using ESRI product; OR
- Two (2) years customer service experience working one-on-one with customers; reviewing legal descriptions, surveys and plot maps using GIS.

Foreign education diploma requires equivalency evaluation to be attached at time of application. Failure to submit proof, will result in disqualification.

Employee Choice Bonus Plan

UNDERSTANDING THE DETAILS



JOIN OUR TEAM BY JUNE 30TH, 2025 TO BE ELIGIBLE!

The following Employee Choice Bonus Plan is designed to allow eligible employees, current active full-time employees or those hired full-time on or before June 30, 2025, to choose one of the three bonus incentive options (one-time option, non-revocable) they would like to receive:



Option 1 **BONUS CASH PAYMENT**

(Default if employee declines to make a choice)

- One month of salary (168 hours) paid in cash over three annual installments at the highest step or top of band of the classification held by the employee at each vesting date.
- Minimum amount of each payment will be \$1,666.67 and a maximum payment of \$3,333.37 (base hourly rate of pay for the classification multiplied by 56). The amount of each payment may change depending upon an employee's individual circumstances.
- Total minimum amount received will be \$5,000.01 and maximum will be \$10,000.02 paid over three installments.
- Applicable taxes will be applied and withheld.



Option 2 **BONUS LEAVE TIME**

- 168 hours of bonus leave time allocated within three annual installments.
- Bonus Leave Time would be administered in the same capacity as standard vacation including compensation rate, request and approval, and reporting expectations.
- Bonus Leave Time will have no cash value and cannot be cashed out at resignation, termination, or retirement.
- Must use the bonus leave time prior to the expiration date, as there is no carry over after the bonus leave time expires.



Option 3 **BONUS DEFERRED COMPENSATION CONTRIBUTION**

- One month of salary (168 hours) paid over three annual installments into the employee's Nationwide Deferred Compensation account at the highest step or top of band of classification held by the employee at each vesting date.
- Minimum amount of each payment will be \$1,666.67 and a maximum payment of \$3,333.37 (base hourly rate of pay for the classification multiplied by 56). The amount of each payment may change depending upon an employee's individual circumstances.
- Total minimum amount received will be \$5,000.01 and maximum will be \$10,000.02 paid over three installments.
- Applicable taxes will be applied and withheld.

Eligibility for Employee Choice Bonus Plan



- Must be an active full-time employee on each vesting date and during the pay period of the payment date to receive each payment.
- Full-time employees on an unprotected unpaid leave on the vesting date are ineligible for that specific payment.
- Employees that separate from full-time service prior to a vesting date will no longer be eligible for that specific payment.
- Employees that receive one or two payments, separate from full-time service and then return to full-time service are excluded from eligibility to receive further payments of any kind.
- Employees that leave full-time service prior to receiving any payments, and then return to full-time service on or before June 30, 2025, are eligible to receive future payments in accordance with their new hire date.

CLASSIFICATION INFORMATION

Unless otherwise provided, this position is part of the Classified Service of the County and is assigned to the Technical Services bargaining unit for labor relations purposes.

Individuals who are in a full-time classification position are required to serve a twelve-month probationary period, which may be extended an additional six months, for a total of eighteen months.

This position is subject to overtime, standby, weekend, holiday, shift, and callback assignments as identified in the MOU (Memorandum of Understanding).

APPLICATION PROCEDURES/FINAL FILING DATE: APPLY BY June 27, 2025 or after 100 applications received.

Oral Examinations are tentatively scheduled for the week of July 14, 2025.

Applications cannot be submitted later than 5:00 p.m. on the final filing date. Make your online application as complete as possible so a full and realistic appraisal may be made of your qualifications.

Resumes will not be accepted in lieu of a completed application.

Attaching your resume and cover letter are an optional feature for those who wish to do so in addition to completing the required application. Information on your resume and cover letter will not substitute for the education, work experience and required fields on the County application. The online County application is the primary tool used to evaluate your job qualifications.

RECRUITMENT ACCOMMODATIONS

Arrangements may be made to accommodate disabilities and religious convictions. Applicants requiring testing accommodations are required to complete and submit the Testing Accommodations Request Form prior to the test administration date. Special arrangements for religious convictions should be included in the "Additional Information" section of the application form.

GENERAL QUALIFICATIONS

- Pass County-paid pre-employment job-related background investigation.
- Perform job duties in a manner assuring a safe working environment for oneself and others.
- Maintain confidential information according to the legal standards and/or County regulations as required.

APPLICATION AND/OR EXAMINATION APPEAL RIGHTS
